UPDATE TO: USDA Issues Recall Notification for Hallmark/Westland Meat

Effective February 25, 2008, J.T.M. is adding 15 lots to our list of products subject to the Hallmark/Westland Meat recall. Consistent with guidance received this week from the USDA's Agricultural Marketing Service (AMS), we have added these products to our list of affected items. These products fall into one of two categories:

- A. Products made using rework materials that were originally produced with Westland Meat products.
- B. Products produced on the same day as products that were made using Westland Meat products.

As stated previously, J.T.M. currently has no commodity beef of any USDA code in inventory from Westland Meat Company.

J.T.M. appreciates your patience and cooperation as we continue to work with the USDA to complete this Westland meat recall as quickly and thoroughly as possible. Based on our internal reviews and the latest guidance from the USDA, we expect that this product list is now complete.

Also, please be aware that J.T.M. has a large inventory of commodity A594 from other manufacturers, and finished goods that are not affected by any potential issues related to Westland Meat Company. We are ready to fulfill any short term product needs you may have, and we remain committed to continuing the highest level of service to our valued customers.

On February 17, the Food Safety and Inspection Service (FSIS) of the USDA issued a notification of recall for Hallmark/Westland Meat Packing Co. Following are excerpts from that release:

“Hallmark/Westland Meat Packing Co., a Chino, Calif., establishment, is voluntarily recalling approximately 143,383,823 pounds of raw and frozen beef products that FSIS has determined to be unfit for human food because the cattle did not receive complete and proper inspection. Through evidence obtained by FSIS, the establishment did not consistently contact the FSIS public health veterinarian in situations in which cattle became non-ambulatory after passing ante-mortem inspection, which is not compliant with FSIS regulations.

This noncompliant activity occurred occasionally over the past two years and therefore all beef product produced during the period of time for which evidence indicates such activity occurred has been determined by FSIS to be unfit for human consumption, and is, therefore, adulterated.

This recall is designated as Class II due to the remote probability that the beef being recalled would cause adverse health effects if consumed. FSIS made this determination because the animals passed ante-mortem inspection but should have been identified as suspect requiring additional inspection after slaughter to determine if there is evidence of disease, injury, or other signs of abnormalities that may have occurred after ante-mortem inspection.

Additionally, the USDA's Food and Nutrition Service (FNS) has issued instructions for School Distributing Agencies regarding destruction of product and reimbursement (see

attached “Hallmark/Westland Meat Company Recall/Destruction/Reimbursement Information”, 2/17/08).

As noted in the FSIS Recall Release, the recall has been expanded from the original hold, and now includes all products produced at Westland Meat Company since February 1, 2006. In light of this, J.T.M. has determined the following:

1. J.T.M. received raw materials from Westland Meat Company during this additional time period. Information on “J.T.M. Products Produced with Westland Meat Products – 2/18/08” has been updated, and the full list is attached.
2. None of J.T.M.’s commercial products are affected by this action, as we have never purchased any raw material from Westland Meat Company for our commercial products.


